**LOCAL ASSOCIATION ACTIVITY** – Association offices and committee work; special assignments; seminar activity and education work; membership and offices in local chapters of Institutes, Societies, etc.

**STATE ASSOCIATION ACTIVITY** – Same as 3 above, but at state association level; include attendance at State Conventions.

**BUSINESS ACCOMPLISHMENT** – Recognized good business conduct, service to clients, imaginative and creative advertising programs, rehabilitation work, land utilization, etc.

### **ROOKIE OF THE YEAR:**

**REALTOR® SPIRIT** – High principles, faithfulness to laws and regulations of The Code of Ethics. Has a furtherance of good real estate practice among other REALTORS® and the general public.

**CIVIC ACTIVITY** – Active in community activities.

**LOCAL ASSOCIATION ACTIVITY** – Is a member in good standing of the Douglas/Elbert REALTOR® Association and has not been licensed for more than 24 months. Award is based on the last 12 month's performance.

**ACCOMPLISHMENTS** – Recognized as having good business conduct, productive service to clients, imaginative and an advocate for the real estate profession.

### **AFFILIATE OF THE YEAR:**

**OUTSTANDING SERVICE** to the membership of DERA by virtue of exceptional performance in the job area.

**PERSONAL PROFESSIONAL INTEGRITY** in accordance with the Code of Ethics of DERA.
